Children enrolled on 8/24/22 = 339. Total Funded Enrollment = 587. We are 57.7% Enrolled.

Our Head Start classes began on August 15, 2022 in all four counties. We are in need of 1 additional HS Lead Teacher in Bucyrus, 1 HS Lead Teacher in Galion, 4 HS Lead Teachers in Marion, 1 HS Lead Teacher in Mt. Gilead and 2 HS Lead Teachers in Mansfield. We are also in need of an Education Supervising Manger for Crawford and Morrow Counties, an Education Mentor/Coach Manager for all four Counties and an Intervention Manger. All of the postings are on our website at www.ohcac.org and we also have the positions posted on Indeed. We need Full-Time Associate Teachers in all four counties.

Our USDA site review was on August 24, 2022 at the Marian Clark Center and they observed the commercial kitchen at that site as well as the Early Head Start class-rooms. We have not had an observation recently due to COVID-19. We appreciate that they are able to restart their visits.

All Lead Teachers, Family Advocates, Data Systems Processors and Managers attended a Bridges Out of Poverty training at Ohio State in Marion during August.

On August 15, 2022 the former Marie English Early Childhood Center opened as the Jan Hulse Head Start Early Childhood Center. We have relocated many Head Start offices to this building. The building offers space for OHCAC staff training, Head Start Policy Council, and OHCAC Board meetings. We are anticipating an October Open House.

We are very grateful to the OHCAC Governing Board for the approval to purchase this property.

## Home Energy Assistance Program

Happy Fall from the Home Energy Assistance Program department!

The 2022 HEAP Summer Crisis Program (2022SCP) is finishing up. The program runs from July 1 through September 30. We have until October 15 to finish any pending/incomplete applications that were started during the 2022SCP season. No new applications can be started after September 30. If a client still needs to finish their pending/incomplete application, please call your local county CAC office.

At the time of this printing the 2022SCP has assisted 510 **households** with utility assistance and referrals, 669 PIPP Plus applications, and 796 applications for State HEAP. There have been 168 fans and 174 air conditioners given out as additional benefits...a final total will be given after October 15.

In addition to the 2022SCP, staff are also busy with the AEP Neighbor to Neighbor fuel funds. These fuel funds started July 1 and are available through August 31.

The 2022-2023 Winter Crisis Program (2023WCP) is fast approaching. It will begin on November 1, 2022 conclude on March 31, 2023.

Our in-house training for staff to finalize all necessary 2022-2023 Winter Crisis Program guidelines will be October 26, 2022.

# Low-Income Household Water Assistance Program (LIHWAP)

The Low-Income Household Water Assistance Program (LIHWAP) is a federally-funded program designed to help income-eligible families with their water and wastewater bills. The program runs from December 2022 through September 30, 2022. However, the grant has been extended and the new grant year will run from October 1, 2022 through September 30, 2023.

Eligible families are those who are at or below 175% of the Federal Poverty Guidelines (FPG) and who have been disconnected (or have a disconnection notice), need to establish new service, or need to pay to transfer service.

Since the beginning of the grant, OHCAC has assisted over 500 plus families with the LIHWAP grant.

If you are in need or know someone who is needing water assistance, please contact one of OHCAC's local Community Action Center's or 740-387-1039 and ask for the water assistance program.



We are excited to get into the fall season. Until then, the Summer Crisis program is keeping us busy with more clients for the program then in the last couple of years, although we are not giving out as many air conditioners or fans this year. Clients are receiving assistance with their water bills using the LIHWAP program. While preparing to roll into the Winter Crisis Program, we are finishing up the CAA program, which ends next month. The OHFA program is still in full effect, which allows us to assist home owners with utilities, taxes, and home owner fees. The personal needs pantry is open and serves area residents with toiletries and household items. Individuals can call the Morrow Center on Wednesdays to request assistance. We recently extended the Wednesday hours to include 9:30 - 11:30 a.m. as well as 1 - 3 p.m. Medication lockboxes are also available. We welcome Angela Neely from the Crawford County office - she is the new Receptionist in Morrow County.

## Home Weatherization Assistance Program

With most of our programs starting a new grant year, we are in full swing at the Energy Office. EPP and Community Connections have started strong this grant year. HWAP has been off to a strong start as well, given we have completed  $1/3^{rd}$  of our inspections for the year. Our sub-contractors have been doing excellent work for the EPP program. We look forward to keeping the momentum rolling through the fall!

## 9 Ways to prepare your home for fall:

## 1. Clean, or possibly replace, your gutters.

If they're clogged, you can end up with a flooded interior and damaged exterior. Clean them, and if necessary, replace them.

## 2. Check for drafts.

Heat loss through windows is responsible for 25-30 percent of heating energy use, according to the U.S. Department of Energy. Weather-stripping is a simple cost-effective way to keep heating costs down.

## 3. Drain your outdoor faucets.

Drain and disconnect all garden hoses from outside spigots to prevent any water from freezing. Not doing this can result to pipes bursting.

## 4. Bring your outdoor furniture in.

If you don't have anywhere to store the items, you should cover them with a waterproof furniture cover.

#### 5. Fix any cracks in your driveway.

Enough small cracks can turn into big cracks, and eventually the concrete can crumble.

#### 6. Change your filters.

FYI: Disposable filters can be vacuumed one time before you replace it, and foam filters can just be vacuumed and not replaced.

#### 7. Fertilize your lawn.

Applying fertilizer will prevent winter damage. Doing this will also help your lawn turn green faster in the spring.

#### 8. Test winter equipment.

Check it all now and make your life easier later.

## 9. Change your batteries.

Once per year you should be checking to make sure all smoke detectors and carbon monoxide devices are working.
